Effective Immediately

As of 7/27/17 Income & Asset review is optional with initial submission of a loan submission to MSF. To opt in for review of Income & Asset documentation at initial submission, simply upload income and asset documentation to the Byte Stored Documents Category “***08-Submission Income/Assets***” as shown below.

Submission of Income & Asset documentation is optional and our current wholesale disclosure request and initial loan submission required document checklist remains unchanged. Loans submitted without Income and Asset documentation will proceed as complete, if all minimum documents are received.
